## 1. Collection of Information

When you opt in to receive SMS messages, we collect:

- Your mobile phone number
- Your messaging preferences (e.g., frequency or topic preferences)
- If relevant, information about your practice related to the services we provide

This information may be collected through web forms, customer service interactions, or direct enrollment into messaging programs.

## 2. Use of Information

We use your phone number and related information to:

- **Messaging frequency may vary**

## 4. Sharing of Information

We **do not sell, rent, trade, or share your phone number or SMS consent information with third parties or affiliates for marketing purposes.**

We may share your data only with trusted service providers who help us deliver our SMS communications. These providers are bound by confidentiality and may only use your information to perform agreed services on our behalf.

## 5. Data Security

We take reasonable administrative, technical, and physical precautions to protect your personal information. However, no system can be guaranteed 100% secure, so we encourage you to contact us if you believe your data may be at risk.

## 6. Third-Party Messaging Services

We may use secure, vetted third-party platforms to manage and deliver text messages. These services are contractually obligated to maintain the confidentiality and security of your data and may not use it for any other purpose.

## 7. Opt-Out Policy

You may opt out of receiving SMS messages from us at any time by:

- Replying **STOP** to any message
- Contacting us directly at the email or phone number below

Once you opt out, you will no longer receive text messages unless you re-enroll.

## 8. Updates to This Policy

This policy may be updated from time to time to reflect changes in legal, regulatory, or operational requirements. When we update this policy, we will revise the "Effective Date" and notify users if the changes are material.
